The Republic of Srpska (hereinafter referred to as "the Borrower") has received a loan from the European Bank for Reconstruction and Development – EBRD (hereinafter referred to as "the Bank") – towards the cost of the Roads Rehabilitation Project. General Procurement Notice (GPN) Ref. 5583-GPN-37543 was published on July 23, 2007. This International Invitation for Tenders relates to contracts for the Rehabilitation of four different sections of Main and Regional Roads of primary national and international importance in Republic of Srpska.

These contracts will include rehabilitation of the following road sections:

Lot 2_2008/EBRD	M14.1 Nova Topola-Srbac-Kobaš-Derвента, length 62,90 km

Lot 4_2008/EBRD	R472 Polje-Podnovlje, length 16,19 km

These contracts are expected to be implemented from September 2008 to March 2009.

The criteria to be used in the tender evaluation is the lowest responsive evaluated Bid price, provided that such Bidder has been determined to be eligible and qualified in accordance with the provisions of the Instructions to Bidders.
